 - c) Affidavit on stamp paper that the consulting firm has not been blacklisted/debarred by any Govt. Semi Govt./Board/Corporation/ Private Organization during the last 05 years.

SCOPE OF WORK

The work involves providing of the interiors and seating arrangement of the Bus at Level-I and II with a small pantry.

CONDITIONS

1. The agency shall make a presentation of the technical bid before the committee constituted by CITCO Management.
2. The time period for execution of the work shall be 60 days from the date of allotment. In the event of the agency failing to comply the time schedule, the agency shall be liable to pay as compensation an amount equal to one percent or which the Engineer-in-Charge may levy on allotted amount for every day. Provided always that the entire amount of the compensation to be paid under provisions of this clause shall not exceed ten percent of the allotted amount. The Managing Director, CITCO may on representation from firm reduce the amount of compensation and this decision in writing shall be final.
3. The agency shall be fully responsible for the designs and specifications of different items prepared by them.

4. The firm shall make necessary revisions as may be required by CITCO in the work and nothing extra shall be paid on this account.
5. In case the representative of the firm is required to visit out station concerning the work, expenditure for the same shall be borne by agency.
6. The agency shall make available the samples of various finishing material to be used in the work.
7. In the event of the failure on the part of the agency to perform in accordance with terms, the CITCO shall be at liberty to cancel the allotment at any stage and shall have the right to make full use of the concept and design prepared by the agency.
8. If the firm abandons the work for any reason whatsoever, CITCO may make full use of the work executed by the agency.
9. The CITCO shall have the liberty to postpone or not to execute any work planned/designed by agency.
10. Conditional offers are liable to be rejected.
11. Income tax shall be deducted as per rules.
12. In the event of dispute the matter shall be referred to Managing Director, CITCO whose decision shall be final and binding on both parties.
13. CITCO reserves the right to reject any or all the offers without assigning any reason.
