This is to inform to all the bidders/agencies that following more amendments/ changes/ alterations are being made in the E-Tender Document for Licensing out CITCO's Baithak at Kalagram, Manimajra, Chandigarh, as per details given below:-

1) The existing Clause 3(ii) and 3(iii) of the E-tender document be replaced with the following clause: -

- (ii) Tenderer/ Bidder having minimum 5 years experience of operating/running any restaurant/ Hotel in any commercial area of repute. Reputed Companies/ brands will be given the preference.

For the purpose, the Bidders will submit documents i.e either ownership or Rent Deed for operating/running any restaurant/ Hotel in any commercial area of repute. If required, Committee may also inspect the same.

Or

Tenderer/ Bidder having minimum 5 years experience of imparting training to individuals employed in reputed Hotels, situated in commercial area.

For the purpose, the Bidders will submit documents/ agreements showing 5 years experience of imparting training to individuals employed in reputed Hotels, situated in commercial area. If required, Committee may also inspect the same.

- (iii) Turnover from operating/running any restaurant/ Hotel in any commercial area of repute by Tenderer/ Bidder should not be less than Rs.1 Crore annually in each year in the immediate preceding last 5 financial years ended 31.03.2018.

For the purpose, please attach Profile and a certificate showing turnover from operating/running any restaurant/ Hotel in the last 5 years, duly certified by Practicing Chartered Accountant. Proof of Balance Sheet, Income Tax etc should also be attached additionally.

Or

Turnover from imparting training should not be less than Rs.1 Crore annually in each year in the immediate preceding last 5 financial years ended 31.03.2018.

For the purpose, please attach Profile and a certificate showing turnover from imparting training in the last 5 years, duly certified by Practicing Chartered Accountant. Proof of Balance Sheet, Income Tax etc should also be attached additionally.

The other terms and condition of the e-tender document shall remain unchanged.
